 Ms. Mindy Wachter reviewed the preliminary June 2020 YTD financial reports. Beginning balances on the Balance Sheet are based on the audited actual information as of June 30, 2019 while the ending balances reflect the YTD balances. The July 1, 2019 Fund Balance of \$14,979,133 represents 54% of total annual expenditures. This will enable HCPA to maintain normal operations even with a state hold back. Year to date revenues exceed expenditures in total by \$5,190,266 The original budget projected a decrease in fund balance of \$1,502,212 while a revised budget projects
