Hmong College Prep Academy Summer School: 2024 Rules and Regulations

All Rules and Regulations located in the Hmong Academy Handbook apply to the Summer School Program. Below are some additional rules that also apply along with some reminders.

1. Class disturbances will not be tolerated. If students are dismissed from class for inappropriate behavior it will count as an absence.
2. Students are not permitted to wander the building. Any student in a restricted area will be subject to disciplinary action. This behavior could result in a suspension from school.
3. Students will NOT be required to wear school uniforms for summer school, but must dress appropriately for school.
4. Violators of the above policies will be terminated from the program. This can occur at any time and all disciplinary action is at the discretion of the Summer School Coordinator and Administration.
5. Students absent for more than 5 days in a row will be removed from the program without prior notification.
6. Students MUST be enrolled in HCPA for the Fall of 2024.

As part of your student's participation in Summer Learning Programs, they will have a Continual Learning Plan (CLP) that works toward the following three goals:

CLP EDL Program Goals

1. Improve academic skills.
2. Gain college & career skills including critical thinking, problem-solving, creativity, social responsibility, initiative and flexibility.
3. Gain social emotional skills including, communication, collaboration, leadership, positive relationships with adults and peers.
